Any dispute related to this agreement will be settled by voluntary mediation. If mediation is unsuccessful, the dispute will be settled by binding arbitration using an arbitrator of the American Arbitration

Association in Rochester, MN. The laws of the State of Minnesota govern this agreement. The parties agree that this Agreement is the entire agreement between them. This Agreement binds and benefits both

UTPB and Client and any successors. Accessibility for the Photo Booth delivery will be available 2 hours before the event. There will be no obstacles (including but not limited to stairs, uneven terrain or water

hazards) making the delivery and setup unachievable. Client will provide a standard electrical outlet for each photo booth. If outside, Client agrees to provide protection from the weather for the booth.
